3. ICLAM2016: Robert Kneepkens

The 25<sup>th</sup> ICLAM Congress 2016 will be hosted in the Netherlands by the GAV (Dutch Association of Insurance Medicine). It is the 4<sup>th</sup> International Congress of Insurance Medicine to take place in the Netherlands after Amsterdam (1901), Scheveningen (1958) and The Hague (1989).

The year 2016 is special in many ways.

- In that year 115 years have passed since the foundation of AIMECA, the predecessor of ICLAM. AIMECA was founded during the second International Congress for Insurance Medicine in Amsterdam, September 24<sup>th</sup> 1901.
- And, in 2016 500 years will have passed since the death of Hieronymus Bosch, the famous Dutch painter (see: <a href="http://en.wikipedia.org/wiki/Hieronymus Bosch">http://en.wikipedia.org/wiki/Hieronymus Bosch</a>). An anniversary that will get a lot of attention in the Netherlands throughout the year. The anatomy of the creatures painted by Bosch will certainly interest all medical doctors.

#### 5.4 **AMUS (UK)**:

The amalgamation of the Doctors society, AMS, and the Underwriters, AMU, has been going on for many months. The final version is not yet complete and we are short of Doctors. To increase the number on the Council we have to change the rules, which will happen mid-March.

In the meantime a half day meeting is planned on Psychiatry for late March but the programme is not yet complete.

Most meetings will be in the evening, which include dinner or drinks.

We need to stay in control of medical advances and concentrate on cutting edge technology which will be important in risk assessment as individuals come forward for insurance who have had successful, say, stem cell therapy for tracheal stenosis. # 5.5 **AMCAP**:

In France, the AMCAP (French assurance medical society) will hold its annual scientific meeting on Friday, May, 20<sup>th</sup> 2011: a whole day dedicated to long term care, and the problems we'll have to deal with in the future as the general population of insured people is becoming older and older. The morning session will focus on the insurance and legal aspect of the question and the afternoon session on some medical key points that often lead to dependence. The trade association for long term insurers in South Africa is called ASISA – the Association of Savings and Investment South Africa. Although the name does not refer to risk products, the management structure has a separate Risk Board looking after protection cover business.

One of the most active committees of ASISA is the Medical and Underwriting Standing Committee (MUSC). MUSC consists of Medical Advisors who are employed full-time in Insurance Medicine, senior underwriters and an actuary. This committee's mandate is to protect our right to underwrite, which requires pro-active actions to ensure that

- Customers are treated fairly
- Products provide value for money, and are understandable for the average consumer
- Risk ratings are evidence-based and non-discriminatory
- Risks for the long-term industry are identified timeously and remedial actions taken or proposed
- Healthy relationships are maintained with important stake holders like the medical association, government, the media, lobby groups and NGO's.
- Underwriting practices comply with our legal framework
- HIV testing is done according to the standards set in our HIV testing protocol.

A separate voluntary association exist for meetings and training of underwriters and medical advisors. This is SASIMU – the South African Society for Insurance Medical Underwriters. It has two chapters, one in Johannesburg and one in Cape Town. Each chapter has quarterly meetings after hours where a guest lecturer presents a topic, followed by a dinner or snacks. These functions are well attended and provide a very good platform for underwriters to socialize and exchange ideas. Venues and eats/drinks are sponsored in turn by the insurers and reinsurers.

The South African market has a very high saturation in terms of private protection cover. This leads to strong competition and subsequent underwriting rate discounts, sometimes beyond levels of comfort. It provides a very challenging situation for the Medical Advisor, who must find a balance between evidence-based and market-competitive rates.

#### 5.7 **ANZIMA (Australia)**:

Founded in 2009, ANZIMA is now a well established force in the Australian and New Zealand life insurance market. The industry has committed considerable funds to support the organization. In return, ANZIMA members are working on guidelines and share relevant information among themselves, but also with the industry. It is noteworthy that ANZIMA has invited a considerable number of Chief Underwriters and Claims managers to join the association.

#### 5.8 **EUMASS (Europe)**:
